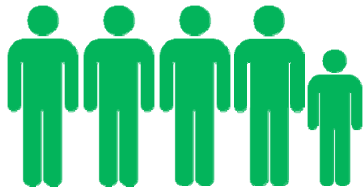

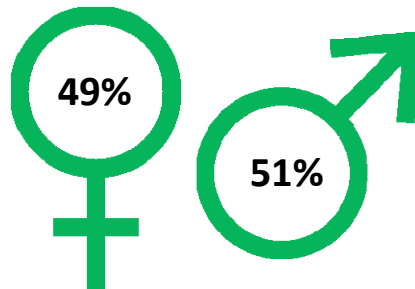

IS A CHILD



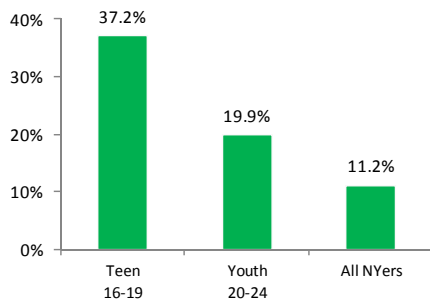
There are 1.8 million children in NYC, or 21.6% of the population.

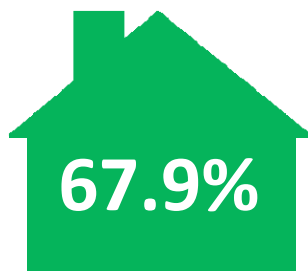
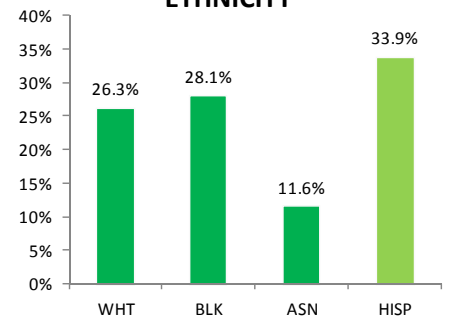


NEARLY 1 IN 3 CHILDREN LIVES IN POVERTY



Over half a million children in NYC live below the poverty level.

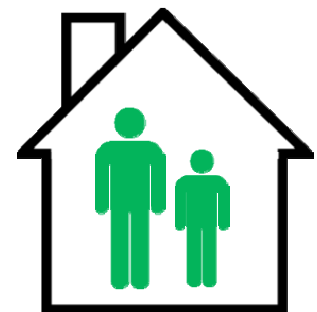
NYC CHILDREN BY RACE AND ETHNICITY*

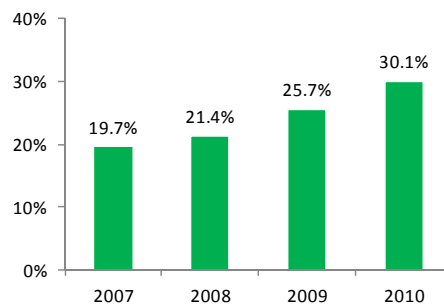
95.4% of NYC's children have health insurance and 51.5% are covered by Medicaid.

Notes: ¹Race/Ethnicity category definitions: White = non-Hispanic white alone; Black = black or African American alone; Asian = asian, Hawaiian or Pacific Islander alone. The categories of Black and Asian are not disaggregated by Hispanic ethnicity and so double-counting may occur. ²For unemployment rates, teens are defined as ages 16-19; youths are defined as ages 20-24. ³For these indicators, Youth households may include households with primary householders who are as young as 15. For all other indicators, age categories are defined as: Children = under 18; Teens = 15-19; and Youths = 18-24, unless otherwise noted.
